3. Sealed bid must be submitted to the Procurement Unit, MOEAP by hand/courier on or before 12:00 hrs. of 31<sup>st</sup> day from the date of first publication of this notice. Bids received after this deadline will be rejected. Bids shall be sealed in an envelope addressing to the Procurement Unit, MOEAP indicating name of contract, contract identification number, bidder's name and address.
4. Bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs. of 31<sup>th</sup> day from the date of first publication of this notice.
5. Bids must be valid for a period of **90 days** counting from the day of bid opening.
6. Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the following address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid.
